The Vendor will be present and set up in McDermont at the assigned space by 4:00 p.m. unless prior arrangements have been made with McDermont. The vendor will operate in a 10' x 10' allocated space during open hours.

The Vendor agrees that it will have present all appropriate goods for sale; with the understanding that no explosive objects, fireworks, material deemed objectionable or pornographic by McDermont and no counterfeit or illegal merchandise may be sold at the Car Show.

The Vendor will move their vehicle or trailers to a designated parking area. This will allow parking that is more accessible for customers.

Vendor shall not allow any other person or group to sell out of its space. Only one vendor per booth.

McDermont Field House, at its sole discretion, reserves the right to deny or withdraw immediately the participation of any vendor. If such occurs, no refund of monies shall be made to Vendor.

McDermont Field House is an equal opportunity entity and does not discriminate on the basis of race, creed, color, or sexual orientation.

I hereby agree to offer for sale at the "Car Show" only such items as are listed on the application. Further, I agree to read and totally abide by the Car Show rules and regulations, and acknowledge full responsibility for all activities conducted throughout the term.
